Dear Mr. President,

Firstly, on behalf of the Republic of Vietnam Government De Jure (RVNGJ), we congratulate you on your recognition by the US nation as the 46<sup>th</sup> President of the United States of America, for the term 2021-2025.

We thank you for helping the Free Vietnamese during your time in the US government. The RVNGJ has been in exile overseas because Vietnamese territory was occupied by the North Vietnamese Communist. Hanoi Communist blatantly violated the Geneva Agreement of July 20, 1954, dividing the country into two parts South, North and Paris Agreement on January 27, 1973 with the Act of March 2 of the same year, invading the Republic of Vietnam on April 30, 1975.

The RVNGJ has continued the struggle of the people of the South and the government of the former Republic of Vietnam before 1975 led by Prime Minister Nguyen Ba Can. After 1975, Prime Minister Nguyen Ba Can continued to lead the government of the RVN in exile overseas.

The Republic of Vietnam Government De Jure (RVNGJ) has continued to operate pursuant the following legal documents: The Constitution of the Republic of Vietnam dated April 1, 1967; The Decrees No. 350-TT/SL dated April 14, 1975 of the President of the Republic of Vietnam appointed Mr. Nguyen Ba Can as Prime Minister; The Proclamation of March 16, 2015 announcing the RVNGJ led by former State Minister Le Trong Quat; The Ordinance of July 2, 2018 defining the composition of the government; The Decree of February 12, 2021 carrying out a major reshuffling of the RVNGJ to regain the national Right of Self-Determination through an anticipating general election as specified in the Paris Agreement for the purpose to democratize the country for bringing Vietnam back into the community of the free world. The political stance of the Republic of Vietnam Government De Jure remains as follows:

-Actively mobilize the United States and other countries in the region as well as India and Australia to stop China's plans expanding by force to occupy the islands of East Asian countries, controlling the circulation of two-thirds of the world's goods, dominating the Pacific and threatening the security and peace of the entire region.

-The RVNGJ continues to call on the United Nations, the democratic countries and especially the new US Government – the world's number one power- to exercise the right of intervention for humanitarian and human rights reasons on the remaining communist countries on the planet North Korea, China, Cuba, Vietnam, Laos so that the people of these countries will so on regain their self-determination, to live worthy of a human being, with dignity being respected, in accordance with the Universal Declaration of Human Rights approved by the General Assembly of the United Nations on December 10, 1948.

-The RVNGJ determines to contribute to the Vietnamese people effort in establishing freedom, democracy and territorial integrity from Nam Quan Gate to Ca Mau Cape. The world situation would continue to change and the threat from China would continue to increase without the United States intervention and maintenance of the world peace.

On behalf of the Vietnamese people, we would like to thank the US Government and would appreciate the US continued support to us in our effort to turn Vietnam into a democratic, mighty country as a front ally to US in the maintenance of security and peace in the East Asia-Pacific region.
